

1. Your registration is valid for carrying out all the Civil, Electrical and Mechanical works in TANGEDCO & TANTRANSCO by participating the tenders invited by all the officers of TANGEDCO & TANTRANSCO
2. This order for registration is issued on the basis that you are not a partner in any firm nor a member of the Co- operative society of contract labour. If it comes to our knowledge that you are a member of the above at a later date, the registration will be cancelled without any notice
3. As per the registration you are eligible only for participating in the tenders and award of contract is not guaranteed.
4. You should produce the Income tax and Sales Tax clearance certificate obtained from the concerned department each and every year and also produce evidence for participating the tender in TANGEDCO for the last two years during the first week of April every year, failing which your registration will be withheld (temporarily cancelled). The registration will be revoked, when the contractor furnish the above particulars at a later date along with the receipt for having remitted an amount of Rs.250/- (Rupees Two hundred and fifty only) in TANGEDCO account.

5. The registration is liable for cancellation when the contractor does not submit his tender Form after purchasing the tender set in three consecutive tenders and when does not participate any tender for continuous period of two years.

7. If the documents produced and the particulars furnished by you are false, your registration will be cancelled without any intimation.
